# Information

## How to complete the form

### Notification

Anyone who sells technical spirits on the Swedish market must notify the Public Health Agency of Sweden. This also applies to those who manufacture, introduce, or import alcoholic preparations and then sell them on the Swedish market. The notification must be made in connection with the start of operations and contain the information requested by the Public Health Agency of Sweden in this form. Please note that the notification is only a registration of the sale of technical spirits and/or alcoholic preparations. You do not have to wait for approval to start your operations. However, you must comply with the requirements of the Swedish Alcohol Act and the Public Health Agency of Sweden's regulations and general guidelines (HSLF-FS 2022:63) on technical spirits and alcoholic preparations. The information in the notification may serve as a basis for planning the Public Health Agency of Sweden's supervision in accordance with the Swedish Alcohol Act.

### The notification relates to

State the type of sale to which the notification relates. Please note that only those who manufacture, introduce, or import alcoholic preparations in their operations and then resell them on the Swedish market must report the sale of alcoholic preparations.

In the event that the notification concerns changes to previously reported information, you must specify the changes to which the notification relates.

Indicate the inspection body used and the company registration number of the inspection body. Please note that this requirement only applies to those selling technical spirits.

### Type of preparation

You do not need to register each individual preparation; you only need to select the category/categories to which the preparation belongs under "Type of preparation".
